

READING ANTHRACITE COMPANY
ACCESS PERMIT WITH RELEASE AND INDEMNITY

In consideration of payment by the undersigned of the amount of One Hundred Twenty-Five (\$125.00) Dollars, Reading

Anthracite Company ("RAC") hereby grants the undersigned the Access Permit, on the following conditions: -This Access Permit is good for calendar year 2017. Access Permits are nontransferable. Should it be found that an Access Permit has been used by someone other than the person who signed for it the Access Permit holder will forfeit the permit for the remainder of the year and will be banned from purchasing another Access Permit in the future. The person found to be using the Access Permit without signing for it will be prosecuted for trespassing on RAC property. -This Access Permit provides the undersigned with permission to be on RAC's properties between sunrise and sunset, excluding those where there is active mining or any other working facilities or any posted properties. RAC property north of Route 209 in the Tamaqua/New Kirk area is NOT available.

The Permit holder should have a copy of the Permit with him at all times when on RAC property. -Permission is granted for recreational activities, excluding however, any overnight camping, any type of dumping on the property, swimming, or any organized events such as races or parties. Further, those granted access are not permitted to have any type of fire on RAC property, and the use of alcohol and drugs on RAC property is strictly prohibited. -Those wishing to hunt need to provide RAC with a copy of a valid hunting permit. -Anyone wishing to take any type of vehicle on RAC property must provide RAC with a copy of proof of insurance and registration for that vehicle. -Access permit holders are encouraged to report to RAC anyone they observe trespassing on Company property. If any such report received leads to the prosecution of a trespasser, then the undersigned permit holder will receive a free permit for the following year. -Permit Holder affirms they are at least 12 years of age. In consideration for the access and permission granted herein, and intending to be bound legally hereby, the undersigned:

1. Release, hold harmless and discharge READING ANTHRACITE COMPANY, its owners, and operators, stockholders, stockholder family members, directors, officers, agents, servants and employees, from any and all claims, demands, actions, and judgments which I ever had, or now have, or may have, or which my heirs, executors, administrators or assigns may have, or claim to have, against any of them and their heirs, successors or assigns, for all personal injuries to me, known or unknown, and injuries to any of my property, real or personal, caused by, or arising out of, the above described activity.
2. Indemnify and hold harmless READING ANTHRACITE COMPANY, and all its named parties referenced in Paragraph 1, from and against any and all liability, claims, suits, demands, legal fees, etc., arising from any personal injury I cause to others while I am on READING ANTHRACITE COMPANY property.

3. Reimburse READING ANTHRACITE COMPANY at replacement cost for any damage caused to any READING ANTHRACITE COMPANY real property or personal property during any of the above described activities.

4. Each Rider is required to comply with all rules and regulations set forth by the Commonwealth of Pennsylvania, Foster Township, Cass Township and any other municipality where riding takes place. A copy of the ordinances issued by Foster and Cass Townships, as of 2017, are attached hereto for your convenience. It is the Rider's responsibility to be fully familiar with said Ordinances and any changes made after 2017. Reading is not responsible for providing any future ordinances or changes, but rather said responsibility rests with the Rider.

5. Any Rider who violates any regulations be they Federal, State or Township or any other municipality, will have their Permit revoked without refund of any monies.

6. Any Rider whose actions cause Foster and/or Cass Townships or any other municipalities to cite Reading shall have their Permit revoked without refund of any monies. Further, each Rider who causes such citation agrees to indemnify and defend Reading against all such citations. The duty to indemnify will require Rider to pay any and all fines, costs and attorney fees incurred by Reading on account of the citation.
